

## NLCU Calendar Contest 2027

### Contest Rules

These Contest Rules are the standard terms and conditions applicable to the NLCU Calendar Contest 2027 (hereinafter referred to as the Contest) administered by Newfoundland and Labrador Credit Union (NLCU) and Prizes awarded by NLCU. The Contest is intended to be conducted on the NLCU Facebook page for eligible entrants residing in the Province of Newfoundland and Labrador only, and shall be construed and evaluated according to applicable Canadian law. Entry in the Contest constitutes acceptance of these Contest Rules.

To be eligible to enter the Contest, an individual must:

- Be a resident of the Province of Newfoundland and Labrador;
- Be 18 years of age or older.

NLCU shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to NLCU for the purpose of the Contest must be truthful, complete, accurate, and in no way misleading. NLCU reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate, or misleading personal details and/or information.

#### Contest Period

The Contest runs from 12:00 a.m. NDT on June 15, 2026, to 11:59 p.m. NDT on July 15, 2026, after which time the Contest will be closed and no other entries shall be accepted.

#### How to Enter

Entrants are to submit a high-resolution, unedited and unaltered image of a scenic photo of Newfoundland and Labrador. Photographs manipulated for artistic purposes by applying digital and/or traditional special effects (i.e. colourizing, toning, collage, photo composites, HDR) will not be accepted. Photo submissions must be in JPG or TIFF format at 300 dpi (or 3600x2700 pixels) and must be in landscape (horizontal) format and full colour. Please note: cropped photos are eligible as it is not changing the basic composition of the photograph. NLCU will determine eligibility in its sole discretion, and reserves the right to disqualify incomplete entries and/or entrants who are unable to submit a high resolution photograph.

For a photo in which a person is recognizable, the entrant must secure a model release from the subject or in case of a minor, the subject's parent or guardian, and provide submission with mentioned photograph. A sample release is available at your local NLCU branch or online at [nlcu.com](http://nlcu.com).

To complete a Contest entry, between June 15 and July 15, 2026, each entrant is to email their photo(s) and model release(s), if applicable, as attachments to [contests@nlcu.com](mailto:contests@nlcu.com) and include, in the body of the email, the full name of the entrant, mailing address, telephone number, and where the image was taken. NLCU will accept more than one (1) photograph per entrant.

By emailing a Contest entry to [contests@nlcu.com](mailto:contests@nlcu.com), the entrant consents to these Contest Rules.

Entries must be received on or prior to the date of the indicated Contest Period entry deadline. Entries will be declared invalid if they are late, illegible, incomplete, forged, or otherwise do not abide by these Contest Rules. No communication or correspondence will be exchanged with entrants except with those selected as a potential Contest winner.

#### License to Use

Entrants retain rights to their photograph(s), however; by entering the Contest, the entrant grants NLCU a royalty-free, nonexclusive license to publicly use their photograph(s) in whole, or in part, in any media now existing or later developed, for any NLCU purpose, including but not limited to advertising and promotion of the company. NLCU will not be required to pay any additional consideration or seek any additional approval in connection with such uses.

## Prizes

Contest Prizes consist of a First Prize of \$250 and four (4) Runners Up Prizes of \$100 each. All cash Prizes are awarded in Canadian dollars.

Winners shall be contacted by NLCU with instructions on how to claim the Prizes.

## Prize Conditions

Prize must be accepted as awarded and cannot be transferred, assigned, or substituted, except at the sole discretion of NLCU. Any unused portion of the Prizes, and any Prize unclaimed after thirty (30) days from the date the entrant is notified of their win, will be forfeited and have no cash value. NLCU reserves the right, in its sole discretion, to substitute a prize of equal or greater value if the Prizes (or any portion thereof) cannot be awarded for any reason.

## Contest Voting

From all eligible entries, NLCU shall select entries for the final round of voting on the NLCU Facebook page and shall assign a seasonal category (Summer, Spring, Winter or Autumn) to each selected entry. Assignment of a seasonal category shall be made at the sole discretion of NLCU regardless of the actual time of year at which the photo was taken. A photo's seasonal category may or may not be indicated when published on the NLCU Facebook page for voting.

The Contest Voting Period for entries selected for the final round of voting begins at 12:00 a.m. NDT on July 23, 2026, and ends at 12:00 p.m. NDT on August 6, 2026. Voting shall be open to the public and conducted solely on the NLCU Facebook page. A "Like" for an entry shall constitute a single vote.

## Winner Selections

The First Prize shall be awarded to the entrant whose photo receives the most "Likes" at the conclusion of the Contest Voting Period. In the event of a tie for First Prize, the winner shall be declared at the sole discretion of NLCU.

For each of the four (4) seasonal categories, NLCU shall be the judge and shall select one (1) winner for a Runner Up Prize for the best photo.

NLCU shall notify the winners by telephone and shall require each winner provide proof that is acceptable to NLCU of the winner's identity and eligibility to participate in the Contest.

## Photos Featured in 2027 NLCU Calendar

Photos featured in the 2027 NLCU Calendar shall be: the First Prize entry winner (which shall be featured on the cover of the 2027 NLCU Calendar as well as within the calendar); winning entries for Runners Up Prizes and; a selection of eight (8) additional photos, chosen by NLCU, from entries that make it to the final round of voting on the NLCU Facebook page.

All entrants whose photo(s) are featured in the 2027 NLCU Calendar shall receive (1) calendar each.

## Indemnification by Entrant

By entering the Contest, each entrant releases and holds the Releasees harmless from any and all liability for any injuries, loss, or damage of any kind to the entrants or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of the Prizes, participation in the Contest, any breach of the Contest Rules, or in any Prizes-related activity. Each entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the Contest, without limitation.

## Limitation of Liability

All issues and questions concerning the construction, validity, interpretation, and enforceability of the Contest Rules or the rights and obligations as between the entrant and NLCU in connection with the Contest shall be governed by and construed in accordance with the laws of the

Province of Newfoundland and Labrador including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.

Language Discrepancy

In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern, and control.
